Terms and Conditions

Direct Debit Conditions

- Direct Debits payments are managed through Payrix.
- This is an ongoing Direct Debit Membership for the entire period of the learn to swim enrolment.
- All Direct Debits are processed fortnightly on a Thursday.
- Any pro-rata amount will be processed on the next payment.
- If a Direct Debit is drawn with insufficient funds in the account, a fee will be charged when the payment is processed on the following payment. The member WILL be contacted by Payrix. Enrolment will be cancelled after 2 attempts.
- Service NSW Vouchers, including First Lappers and Active Kids, once redeemed will be added to
 customer Direct Debit account. Payrix will not deduct payments until allocated voucher amount has
 been exhausted.
- Members are responsible for paying any Debt Collection fees that may be incurred. Any account in debt may not be considered for future enrolment within the Aqua Learn to Swim program.
- For payment options and queries, please contact your enrolled venue's Aqua Learn to Swim team.

Time Stop Policy

- Make-up lessons are not offered. However, customers are welcome to 4 complementary time stops within 1 (one) calendar year.
- A time stop application form must be completed prior to the requested time stop date and time.
- Forms can be completed online and lodged at www.aqualearntoswim.com or in person at the venue.
- A single time stop covers one lesson and multiple time stops can be used consecutively.
- Time stops work on a pro rata basis to when first direct debit registration occurred.
- Time stops cannot be backdated.
- Time stops are not transferrable.
- Unused time stops do not carry over to next calendar year.

Cancellation Policy

- Cancellations must be received in writing with 14 days' notice.
- All pro-rata and outstanding fees must be paid in full prior to cancelling.
- Fees are non-refundable.
